### THIRD SUNDAY AFTER EASTER

**The paschal joy which now permeates our liturgy and hopefully our lives, is inseparable from the freedom from sin and the hope of our participation in divine life with Our Risen Lord. Like a seed this blessed joy is destined to grow and blossom into the Beatific Vision, seeing God face to face with the eyes of the soul IF we stay near Our Good Shepherd and hear His voice.**

**Hopefully our Lenten fasts and sacrifices have made us stronger. How are we able to persevere in the joy and grace that we accomplished this past Lent? In the words of St. Peter's epistle today it is by being "strangers and pilgrims" to the things of this world. In other words by not becoming too attached to them.**

**Let us not fall back but rather continue to grow closer to Christ realizing the pleasures of this world are only transitory. We will have to leave EVERYTHING behind one day—including our body! Our first Pope and Good Shepherd to the flock has encouraged us to refrain from carnal desires that war against the soul!**

### **6th Circuit Court Rules Planned Parenthood**

#### **Defunding Unconstitutional**

The 6th Circuit Court has ruled unconstitutional the Ohio law cutting five federal grants to Ohio abortionists. Taxpayers **MUST** continue to underwrite these grant projects for the abortion industry. We see that babies are seen as a disease rather than a blessing from God! Unelected Federal Judges are overriding the voice of the people and our legislatures!

On February 22nd, 2016 Ohio Governor John Kasich signed House Bill 294 (lead sponsors Representatives Bill Patmon and Margy Condit) to block abortionists in Ohio from qualifying for five federal funding programs administered by the Ohio Department of Health. The bill redirected state-administered grants--approximately \$1.3 million--away from Planned Parenthood and other abortion providers. Planned Parenthood filed suit May 11, 2016 in federal court to block the law from being enforced. Judge Michael Barrett granted Planned Parenthood a temporary stay then a permanent injunction, thus the law has not been in effect and Planned Parenthood has operated as usual. The law would not affect Medicaid reimbursements, a large source of government funding, which still goes to this leading abortion chain.

**The Third National Day of Protest against Planned Parenthood will be Saturday, April 28.** In Dayton, our rally will be at **9:00 AM at the PP facility at 224 N. Wilkinson St. downtown.** Plenty of adjacent free parking. Our local protest is one of at least 115 nationwide and five in Ohio on that day. Please plan on attending!
